What is delivered to you?

1. Custom Industrial Facility Concept Design for factories, processing plants, manufacturing lines, warehousing/logistics facilities, or resource-sector operations—optimized for workflow efficiency, sustainability, safety, and future scalability. This may include:
 - a) 2D Industrial Layout Plan detailing equipment zones, production flow, material handling routes, functional spaces, circulation paths, loading areas, utilities placement, and access/egress points.
 - b) Exterior Elevations (generated from the 3D model) showing industrial cladding systems, façade treatments, grade levels, door and bay sizes, ventilation/roof equipment locations, and service interfaces.
 - c) 3D Rendering of the facility and site, illustrating massing, structure, circulation, and operational context for stakeholders, investors, and permitting authorities.
2. Industrial Site Plan including yard layout, truck and equipment circulation, loading zones, setbacks, service corridors, utility routing, drainage concepts, environmental buffers, sustainability features, and standard site-planning metrics (lot dimensions, distances to boundaries, access roads, parking/laydown areas).
3. Materials, Systems & Performance Features List specifying recommended industrial-grade materials, high-durability finishes, sustainable design elements, fire-resistant components, ventilation and safety considerations, and elements supporting code compliance and long-term operational performance.




What optional services are available to you?

The following professional services are *not* included in the package, but are available for an additional fee:

- **Professional Engineer review**, approval, and/or seal including structural, mechanical, electrical, fire protection, or civil engineering as required.
- **Licensed Architect review**, approval, and/or seal of all design documents.
- **Cross Section** which details foundation (footings, basement walls), floor assemblies (joists, beams), wall construction (studs, insulation, vapor barrier), roof structure (rafters, trusses), floor-to-ceiling heights, stair details (rise, run, headroom), material layers (drywall, sheathing, siding). The Cross Section is typically completed by the construction contractor, but Vetruiviex can manage this process and engage with a construction contractor to prepare this document.
- **Structural Drawings** which detail foundation plan (type, size, dimensions), floor and roof framing plans, columns, bearing walls, and structural details. The Structural Drawings are completed by a licensed structural engineer, but Vetruiviex can manage this process and engage with the structural engineer to prepare this document.

The following legal services are available for an additional fee from a qualified lawyer from Vetruiviex's legal partner law firm, *Procido LLP*:

- **Review of design and site plans for compliance** with applicable federal, provincial, municipal, and First Nation laws, codes, and regulations.
- **Borrower-side legal counsel** if financing the facility or site acquisition.
- **Real estate transactions** for purchasing land for industrial development.
- **Procurement management**, including Requests for Proposals (RFPs) and contract award processes.
- **Negotiation, drafting, and execution of Construction Contracts** for industrial facility builds.
- **Negotiation, drafting, and execution of Services Contracts** for site preparation, landscaping, or specialized industrial installations.
- **Permit, licensing, and rezoning applications**, including regulatory submissions and compliance support.
- **Dispute resolution services**, including mediation, arbitration, or court proceedings if conflicts arise during development or construction.
